



Beaumont Hamel 100th Anniversary 12 Days: England, France & Belgium

Saturday, June 25 - Wednesday, July 6, 2016



Just after dawn on July 1, 1916, over 800 brave young Newfoundlanders advanced from the trenches on the first day of Battle of the Somme. The following day, only 68 of them could stand for roll call. A day which forever marked the Dominion of Newfoundland. On the preserved battlefield now stands the majestic caribou, the emblem of the Royal Newfoundland Regiment, in honour of these men who served.

July 1, 2016 is the 100th Anniversary of Beaumont Hamel. Join us for an exceptional and emotional journey to visit Beaumont Hamel, be a part of the official remembrance ceremony, and explore other sites of Newfoundland's history in Europe, including the four other caribou monuments in France and Belgium.

With a full-time tour leader, a balance of guided activities and free time to explore on your own, this tour will deliver an exceptional experience for you.

With an intimate group size limited to 25 people, our tour includes:

- A direct flight to London from St. John's, and three days/two nights in London based in a central hotel, including guided sightseeing, unique visits, and free time.

TERMS AND CONDITIONS

RESERVATIONS AND DEPOSITS:

Reservations should be made as early as possible to ensure the departure of your choice. A deposit of \$750.00 is required at the time of registration. Your reservation is confirmed upon receipt of your deposit and application form. No reservations will be accepted without a signed application form.

REFUND OF UNUSED ARRANGEMENTS:

Because the rates of Pauwels Travel Bureau Ltd. are based on group participation, no refund can be made for any tour accommodation or tour service or tour feature not taken. If cancellation occurs while the tour is in progress, no refund can be made for the tour portion not taken. We strongly suggest that to allow for any unexpected contingencies, you purchase the all-inclusive insurance.

CANCELLATION POLICY:

Refund of deposit is made if cancellation is received in writing by Pauwels Travel Bureau Ltd. more than 90 days prior of the departure date of the tour less a \$500.00 non refundable administrative fee per person. For cancellation received in writing 90 days prior or less the following cancellation charges apply:

90 days to 46 days before departure: 25% of tour cost 45 to 31 days before departure: 50% of tour cost Within 30 days prior to departure: 100% of tour cost
